## What to Have Ready for a Bedside Visit

A little preparation helps a bedside notarization go smoothly. Before we arrive, try to make sure the signer has a valid, government-issued photo ID, such as a driver's license, state ID, or passport, with a name that matches the document. If the patient's ID isn't available, let us know when you book, since there are sometimes lawful alternatives we can discuss. Have the complete document ready but unsigned, because most notarizations require the signer to sign in the notary's presence. If witnesses are required, mention it ahead of time so we can help coordinate them. Taking these small steps in advance means the visit itself stays brief and calm, which is exactly what everyone wants in a medical setting.

## A Word on Signer Awareness

One question families often have is whether a hospitalized loved one can still sign. A notary's role is not to judge medical capacity, but we confirm the signer appears aware, willing, and able to understand the signing and is not being pressured. If a patient is heavily medicated, unconscious, or unable to communicate clearly, we may not be able to proceed, and we'll always tell you honestly and kindly if so. When in doubt, it's best to arrange the visit when the patient is most alert, and we're happy to help you plan around that.
